20.B - APPROVAL OF FINANCIAL MANAGEMENT AND REPORTING CHANGES FOR CAPITAL IMPROVEMENT PROJECTS (Finance Director)

The City is continuing the ongoing transition to financial best practices. Some of the major cost centers for any municipality are the capital project budgets. It is imperative that a municipality have a financial structure that allows the Finance Department and operating departments (usually Public Works) to accurately track, analyze, and manage the capital projects. City staff has, through significant staff hours, managed capital projects through an ineffective financial structure. The requested actions are to change the capital project financial structure to meet municipal best practices. This process was developed in coordination with the Public Works Department. This change in financial process will greatly improve the Finance and Public Works Departments' ability to manage the City's capital projects.

Recommendation:

Move to adopt a resolution (Attachment 1) approving the following:

- 1. The necessary budget amendments to allow for a change in financial management and reporting of Capital Improvement Projects (CIP) to align with municipal best practices; and
- 2. The delegation of authority to the City Manager to approve all necessary budget amendments to reduce the budget in the Organization and Objects in which the capital projects were formally budgeted.

WaterSmart software is an effective water conservation tool that provides customer engagement and data analytics regarding water usage. This action seeks to approve a new five-year agreement with WaterSmart Software, Inc. that includes a web and mobile customer portal for interactive and personalized online data for customers to access, utility analytics software for City staff to utilize, customized Home Water Reports, and leak alert and high use notifications.

Recommendation:

Move to adopt a resolution (Attachment 1) approving a five-year agreement (Attachment 2) with WaterSmart Software, Inc. to continue the WaterSmart program from 2022 through 2026 for a total cost of \$239,500 and authorizing the City Manager to sign the agreement on behalf of the City.

The City Council introduced the attached ordinance on November 2, 2021, which includes amendments to language in the water and wastewater chapters of the Benicia Municipal Code. The amendments are clean up changes and do not affect water or wastewater rates. The changes delete outdated sections and clarify language for customers' better understanding.

Recommendation:

Move to adopt the ordinance (Attachment 1) of the City Council to amend Sections 13.12.010 (General Water Service Rates) and 13.52.030 (General Sewerage Service) of the Benicia Municipal Code and finding the ordinance exempt under the California Environmental Quality Act.

20.E - AUTHORIZATION OF CONTINUATION OF VIRTUAL MEETINGS (City Attorney)

The State recently enacted AB 361, amending the Brown Act. AB 361 allows the City to continue with virtual meetings, as long as certain findings are made that in-person meetings would present an imminent risk to the health and safety of attendees. On October 5, 2021, the City Council adopted Resolution 21-127 with necessary findings to maintain virtual meetings. State legislation requires that local jurisdictions adopt a resolution every thirty days to affirm such findings in order to continue virtual meetings for all its legislative bodies. During the state of emergency, this item will be presented to Council at least every thirty days.

Recommendation:

Move to adopt the resolution (Attachment 1), affirming the findings that current conditions authorize virtual (teleconference) public meetings, and authorizing the City's legislative bodies to conduct virtual meetings.

21.A - UPDATE ON FACE COVERINGS MANDATE AND THE CONTINUATION OF VIRTUAL MEETINGS AND CONSIDER RESCINDING OR MODIFYING RESOLUTION NO. 21-88 (City Manager)

On August 24, 2021, Council passed Resolution No. 21-88, requiring face coverings be worn in all indoor public settings in the City. The resolution ordered that the item return for review after six weeks and, additionally, when the City is not in the substantial or high transmission of COVID-19, as defined by the Centers for Disease Control (CDC), for a thirty-day period.

On September 21, 2021, Council discussed protocols for City Council Chambers and directed staff to continue with virtual meetings with the same review requirements as the face covering mandate.

At the October 19th, 2021 City Council meeting, Council directed staff to bring back the face covering mandate, as well as the continuation of virtual meetings, for further Council review and discussion.

Recommendation:

Receive the update and provide direction to staff regarding the face covering mandate, as well as the continuation of virtual meetings for the City's legislative bodies.

- 21.B HOLD PUBLIC HEARING, CONSIDER AND COUNT PROTESTS, AND CONSIDER ADOPTION OF RESOLUTION ADOPTING FINAL DRAFT WATER AND WASTEWATER RATE STUDY AND AMENDING MASTER FEE SCHEDULE TO SET WATER SERVICE RATES, WATER SHORTAGE CONTINGENCY RATE SURCHARGES, AND WASTEWATER SERVICE RATES (Public Works Director)

The City of Benicia is proposing to gradually increase its water and wastewater rates over the next five years to provide adequate funding for operating and maintenance expenses, and the most critical capital improvements needed to support safe and reliable water and wastewater service.

On November 16, 2021, Benicia City Council will hold a public hearing to consider adoption of the updated water and wastewater rate schedules, updated rate methodologies, and proposed water shortage contingency rate surcharges. The notice of public hearing was mailed to customers on September 13, 2021. As stated in the notice, if customers wish to protest the proposed rate increases, they have the opportunity to do so, in writing, prior to the close of the public hearing on November 16, 2021. A final count of written protests will be determined after the close of the public hearing and reported verbally.

Recommendation:

Conduct a public hearing and move to adopt the resolution (Attachment 1) adopting the Final Draft Water and Wastewater Rate Study (Attachment 2) and authorizing the amendment of the Master Fee Schedule setting water service rates, water shortage contingency rate surcharges, and wastewater service rates.

21.C - MODIFICATION OF EXISTING UTILITY DISCOUNT PROGRAM (Public Works Director)

The City has a Utility Discount Program that provides financial support from the General Fund to qualifying low-income customers. Currently, qualifying residential customers can receive a \$19.20 discount on water bills. Residents of Casa de Vilarrasa senior apartments receive a 50% reduction of bimonthly wastewater bills. This action proposes increasing the discounts for qualifying customers' water bills and restating the City's intention to continue the wastewater bill discount for Casa de Vilarrasa residents.

Recommendation:

Move to adopt a resolution (Attachment 1) approving modifications to the Utility Discount Program as follows:

- 1) Increasing the low-income water discount for qualifying low-income residential customers from \$19.20 per bimonthly bill to \$34 per bimonthly bill in 2022, \$36 per bimonthly bill in 2023, \$38 per bimonthly bill in 2024, \$40 per bimonthly bill in 2025, and \$42 per bimonthly bill in 2026, paid for by the General Fund; and
- 2) Continuing the current low-income wastewater discount of 50% off the fixed wastewater service charge for Casa de Vilarrasa residents, for calendar years 2022 through 2026, paid for by the General Fund.

The decision of the City Council is final as of the date of its decision unless judicial review is initiated pursuant to California Code of Civil Procedures Section 1094.5. Any such petition for judicial review is subject to the provisions of California Code of Civil Procedure Section 1094.6.
